Brief Description of Undergraduate Courses Taught: (Course Title – Code: Description)

- 1. Principles of health care management (HIMT -414): The course introduces students to the principles of health care management and planning. Emphasis is placed on the components of the management model, leadership, and communication in health care organizations.
- 2. Basic Medical Emergencies (EMS 221): This course is designed to provide the students with the emergency medical knowledge and skills necessary to care for the sick and injured in a pre-hospital setting.
- 3. Clinical Paramedic field Practice, Basic (EMS -315):): EMT-Basic has been developed to encourage students to work as pre-hospital health care providers. It is an exploration of the foundations necessary for mastery of the basic topics of clinical practice (Basic) for the out of the hospital environment.
- 4. Clinical Paramedic field Practice, Intermediate (EMS 325): EMT-Intermediate is an exploration of the foundations necessary for mastery of the advanced topics of clinical practice (Intermediate) for the out of the hospital environment.
- 5. Clinical paramedic Practice Administration (EMS 423): This field experience is designed to expose the soon to graduate student to EMS related administration concepts. It will equip the student with the knowledge, experience, and methods to understand the importance and achieve these concepts. And so, the student will get familiarized with the following terms and concepts: Leadership in EMS, continuous quality improvement & quality assurance, reducing adverse events in EMS, EMS system performance measures & benchmarking in EMS, Paramedic's legal duties, Education and EMS advocacy.
- 6. Paramedic Field Practice, Advanced (EMS -415): This course provides the paramedic student with an opportunity to apply previously learned Advanced knowledge and skills in a supervised clinical setting.
- 7. Applied Pharmacology (EMS -223): This course will build on Paramedics understanding of drug use and administration. Students will learn how drugs are chosen for particular effects. The pharmacological principles of pharmacokinetics, pharmacodynamics, adverse effects, contraindications and precautions will be described using examples from different drug classes.

- 8. Special Population (EMS -411): This course will allow the student to explore issues related to the compassionate, patient-centered care of special populations including geriatric, patients with special challenges and a variety of underserved groups. Students will learn about the functional assessment of the elderly and how to adapt their interview and physical examination techniques to the developmental, functional, educational and social level of individual patients. They will learn to identify vulnerable populations and to respond to the health disparities vulnerable groups often experience.
- 9. Airway & Respiratory Emergencies (EMS -312): Didactic theory in basic and advanced airway management to give students the chance to learn, practice and demonstrate their ability in applying many airway skills used in resuscitation. Students increase their awareness of various airway products and skills required.
- 10. Medical Emergencies (EMS 311): This course with various medical emergencies will be presented. Description causes, complications, signs and symptoms, and prehospital management of patients with a diagnosis of medical emergencies. Establish the detailed physical examination process for medical emergencies that commonly occurs in pre & in hospital setting. Review anatomy of the structures and discuss specific findings, symptoms, and management consideration for common diseases.
- 11. Trauma 1 (EMS 322): Principles of Trauma Assessment and treatment priorities will be explored in this course. Trauma overview, mechanism of Injury, Injury Prevention, bleeding, soft tissue trauma and buns. This course will equip students working in the prehospital emergency care with foundations of knowledge to apply patient care in trauma situations. To develop knowledge and understanding of the resources available to assist a paramedic at a trauma scene.
- 12. Trauma 2 (EMS 412): This course will emphasize the rapid assessment and life-threatening interventional skills in a scenario-based venue. Critical thinking skills will be sharpened by practical scenarios conducted in out-of-hospital settings. Establish the detailed physical examination process for trauma emergencies that commonly occurs in pre & in hospital setting.
- 13. Critical Care Practice (EMS 422): This course will prepare the student to deliver outstanding advanced critical care when moving patients from one health care facility to another via ground or air ambulance or when responding directly to the scene of a medical or trauma event. He will learn how to perform patient assessments and provide invasive out-of-hospital care.
- 14. Foundation of Paramedic Practice (EMS -225): This course will provide the student with conceptual knowledge of the medical responsibility to be assumed upon program completion, Credentialing, and position placement under medical direction. Medicolegal implications will be presented. Illness and injury prevention, medical-legal issues and ethics will also be included.

- 15. Cardiovascular Emergencies (EMS 321): Didactic theory and hands-on practice in this Course is designed to instruct the student in Basic ECG Interpretation, Cardiac function, electrophysiology, conduction disturbances, treatment and Resuscitation modalities will highlight in this course. Focusing in impaired cardiovascular function resulting in life threatening arrhythmias. Preparing student to clinical component related to cardiac emergencies.
- 16. Clinical Assessment (EMS -224): Didactic theory in physical examination contains foundational content to guide students' approaches to history taking, interviewing, and other core assessment skills, as well as fully illustrated, step-by-step techniques that outline correct performance of physical examination.
- 17. Research project (EMS 424): This course is an introduction to basic research methods and statistical procedures used in Emergency Medical Services research. The course will focus on research, planning, Literature review, methods of data collection, analysis display, literature citation, interpretation, and evaluation of articles in the emergency healthcare. This course will also cover fundamental concepts of evidence-based practice and overcoming barriers in the implementation of evidence-based care; how to present new trends in EMS practice and disseminate evidence to other emergency care professionals. At the end of this course student will prepare a research proposal and get IRB.
